Father ordered son to shoot victim, **JPSO** says

A heroin dealer ordered his 18-yearold son to shoot regular customer Brian Rodrigue, who died of multiple gunshot wounds, Jefferson Parish Sheriff's Office investigators said.

Detectives arrested the accused dealer, Keyon Robin, 34, and his son, Keyon Smith, 18, on warrants for second-degree murder, said Col. John Fortunato, spokesman for the department.

Sheriff's Office dispatchers received reports of gunfire just before 10 p.m. Monday in the 1600 block of Apache Drive in Harvey. Deputies arrived and found Rodrigue, 37, lying in the street. He was pronounced dead.

The New Orleans Police Department has made substantial progress in the way it responds to sexual and domestic violence cases, federal consent decree monitors said at a public hearing in federal court Thursday.

Lead monitor Jonathan Aronie said that while the sex crimes unit still needs improvement, it has reviewed and improved more than 40 policies, including those governing the use of body-worn cameras, crisis intervention and use of force.

"The New Orleans Police Department is taking the right steps to bring itself into compliance," Aronie said in reference to the consent decree, which was issued in June 2012 in response to civil rights violations and other misconduct by the department.

Judge issued stinging rebuke of ex-DA Morel

With a stinging rebuke, U.S. District Judge Kurt Engelhardt sentenced former St. Charles Parish District Attorney Harry Morel Jr. to three years in prison for obstructing the federal investigation into Morel's sexual harassment of women with pending court cases

Now the transcript of that hearing has been made public.

In his statement, Engelhardt chastised Morel for breaking the public's trust as an elected official.

"Standing alone and in the absence of any other facts, the charge of obstruction of justice is significant even without an examination of the underlying facts," Engelhardt

Hustler Club sues over ruling on placement of signs in Quarter

Larry Flynt's Hustler Club has filed a lawsuit seeking to overturn a ruling that the strip club's placement of 48 Hustler magazine covers on its Bourbon Street club vio-

The suit comes a month after the City Council denied the club's appeal of the ruling made by the Vieux Carre Commission, which found that the magazine covers were part of the club's signage and violate rules prohibiting excessive signage.

The club's attorney, Michelle Cumberland, argued before the City Council that the magazine covers qualify as art and are protected by the First Amendment.

successfully collaborating with advocates and experts in sexual assault to create a more "community-oriented policing process." Evidence for that can be found in a 97 percent increase in reports of sexual assault this year compared to the same period in 2015, he said.

The news comes nearly two years after a November 2014 inspector general's report accused the NOPD of mishandling hundreds of reported sexual assault abuse cases. The report said five New Orleans police detectives entrusted to put rapists in jail and protect children from abusers routinely failed to perform proper investigations.

In an audit released in June, the inspector general said the department's sex crimes investigators and supervisors had properly documented and reviewed every rape case reported during a three-month period in 2015. Inspector General Ed Quatrevaux said the report represented a "remarkable turnaround."

Police Superintendent Michael Harrison on Thursday praised the Special Victims Section.

will continue to work aggressively to do everything we can to prevent sexual violence from happening and to support survivors of these terrible crimes.'

In early 2015, Harrison put Doug Eckert in command of the department's Criminal Investigations Division, which includes the Special Victims Section. At the hearing, Eckert said the section has overhauled the way it reports, documents and investigates sexual assault cases

To ease the workload on detectives and improve responses to survivors, the department has hired three civilian investigators, Eckert said. They have also hired three social workers to work with survivors and encourtim-centered approach."

Eckert said the Special Victims Section is taking an aggressive approach to the way it processes rape kits, thanks to a \$1 million grant from the Department of Justice in 2015. The Police Department now collaborates with the Orleans Parish District Attorney's Office and State Police to track and test rape kits at the State Police crime lab.

Eckert said the department has also improved its DNA testing capacity by hiring four crime lab analysts.

It plans to hire another three in the near future, he said.

Marrero man accused of stabbing nephew

A Marrero man who was "mad at his entire family" stabbed his nephew multiple times Thursday evening, authorities said.

Charles Harris, 47, of 2005 Gladstone Drive, was booked with aggravated second-degree battery, a Jefferson Parish Sheriff's Office arrest report said.

The victim, a 39-year-old man, was taken to University Medical Center in New Orleans in critical condition.

Relatives at Harris' home told deputies he and his nephew began arguing Thursday around 5 p.m.

Authorities didn't say what caused the disagreement.

But Harris went to his bedroom and retrieved a kitchen knife as the argument escalated. He returned to the living room and allegedly stabbed his Charles Harris

nephew four times in the back and arm, the report said. Harris's nephew ran outside and collapsed to the ground.

When deputies arrived, Harris walked out the front door and yelled, "Yeah, I stabbed him. I told him not to come at me like that," the arrest report said.

Harris told deputies he stabbed the victim because he was mad at his entire family. Deputies took him into custody and booked him at the Jefferson Parish Correctional Center in Gretna.

Harris has a conviction for possession of cocaine, according to Jefferson Parish court records. He was being held still being held at the correctional center in lieu of a \$75,000 bond.
